The criteria for this scholarship are:

- It is open to all public, private and home-schooled high school students in Nevada County, who are in grades 9 to 12 as of August 15, 2018, or the home-schooled equivalent.
- Essay required on the one-page question attached to this announcement. The essay must be the applicant's original work, no more than 500 words in length, typewritten or computer generated, with double-spacing and 1-inch margins on all sides. The applicant's name must not be included in or on the essay.
- The application form must be completed and returned to the address below with the essay by Monday, October 15, 2018. Essays received after this date will not be accepted.
- The criteria for evaluating essays will emphasize a well-reasoned and well-stated argument. The
 position taken in the essay is immaterial. What is essential is that the argument be
 well-reasoned and supported by evidence, arguments, or other rhetorical means of
 persuasion. Grammar, spelling, punctuation and clarity of thought and expression are the
 remaining criteria.
- No affiliation with the Nevada County Bar Association or its members is required for entry, but no person related to an entrant may participate in judging entries.

QUESTION

The U.S. Constitution sets out a system of government with distinct and independent branches—Congress, the Presidency, and a Supreme Court. These three separate branches share power, and each branch serves as a check on the power of the others. "Ambition must be made to counteract ambition," James Madison explained in Federalist 51, explaining that these checks and balances preserve political liberty. George Washington, however, noted that political parties, though they may "now and then answer popular ends," in the course of time would become "potent engines, by which cunning, ambitious, and unprincipled men will be enabled to subvert the power of the people and to usurp for themselves the reins of government."

Please address our system of governance and the interaction between political parties and the three separate branches using the following questions to guide your analysis:

What happens if the legislative and executive branches are controlled by the same party? Does the separation of powers outlined in the U.S. Constitution provide the necessary check on a single party obtaining too much power? What changes do you think could account for one party yielding a disparate amount of influence? Would a change to parliament-style of governance help? What about changes such as eliminating the electoral college or reallocating the number of senators a state is allotted based on population?
