## REDUCTION OF PARTICULAR KINDS OF CERTIFICATED SERVICES

## RESOLUTION NO. 12-23/24

WHEREAS, the Board of Trustees ("Board") of the Nevada Joint Union High School District has determined that it is in the best interests of the District and the welfare of the schools and the pupils thereof that the particular kinds of services set forth herein must be reduced or discontinued; and

WHEREAS, it is the opinion of the Board that because of the aforementioned reason, the number of certificated employees of the District must be reduced; and

WHEREAS, this Board does not desire to reduce the services of regular certificated employees based upon reduction of average daily attendance during the past two years.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of the Nevada Joint Union High School District as follows:

- C. That due to the reduction or elimination of particular kinds of services, the corresponding number of certificated employees of the District shall be terminated pursuant to Education Code section 44955.
- D. That the reduction of certificated staff be achieved by the termination of regular employees and not by terminating temporary and substitute employees.
- E. That "competency" as described in Education Code section 44955(b), for the purposes of bumping, shall necessarily include all credentials, authorizations, training and experience possessed by the employee to be bumped that are relevant to the subject matter area of the position to be filled, including BCLAD authorization.
- F. That, as between certificated employees with the same seniority date, the order of termination shall be determined solely by Board-adopted criteria.
- G. That the District Superintendent or designee is directed to initiate layoff procedures and give appropriate notice pursuant to Education Code sections 44955 and 44949.
